
the **SAFETY 21** empowered by the Italian State bodies and by the Italian Government – as right holder entrusted with the exclusive management of national assets (state property) and municipal property belonging to central Italian state organs and Italian self-governments, including any legal persons and organizations established by these state authorities – in the scope of the enforcement of the non-payment of fees, tolls, surcharges and other administrative fines (penalties) resulting from committing public road offenses, unauthorized use of vehicles in public areas and on public roads, improper use of public road and public space as well as inappropriate use of vehicles, and in relation to that,


the **LOGICALL CESKA REPUBLIKA** shall act with full power and to the extent of full legal claims in order to enforce the fees, surcharges and other administrative fines detailed above against **EU and non-EU natural persons and EU and non-EU resident companies**, which debt recovery activity is set out in its official license, including of sending out payment notification, retrieving information on vehicle keeper, vehicle owner and other data required for proper identification from the competent register, initiating order for payment and European order for payment procedures, European small claims procedures, as well as other judicial and extrajudicial procedures – including but not limited to enforcement procedures, notary procedures, enforcement procedures in other member states, as well as any other European procedures – in front of competent Courts and any other authorities in the name and on behalf of the right holder, as well as to take all relevant written and oral statements in relation to the above proceedings. The Parties state furthermore, that the above procedures do not constitute infringement or criminal procedures.

On the basis of this present power, the **LOGICALL CESKA REPUBLIKA** is entitled to mandate and empower its affiliated companies of legal interest, as well as other participating individuals, such as legal representatives or other agents to conduct the above-mentioned debt recovery activities and any related procedures authorized by present power. Present power also entitles the **LOGICALL CESKA REPUBLIKA** in particular to initiate and to carry out enforcement proceeding with regard to debt collection.

The empowerment is valid until cancelled in writing.
